WGSBs' Priorities

Over the course of the last year (2019/2020) the work of the Board focused on Exploitation, Engagement & Participation and Effective Management of the Safeguarding Board.

Up until March 2020 it was envisaged that some of these priorities would be taken forward into 2020/2021. However, due to the Covid-19 pandemic the Board decided to park the aforementioned priorities and instead all safeguarding priorities have been set against the backdrop of Covid 19.

In setting the priority area/focus for the forthcoming year the Board has due regard to its statutory responsibility to meet the core functions:

- Raising awareness of the Board's objectives to protect and prevent adults and children from becoming at risk of abuse, neglect and other forms of harm, and to provide information about how this might be achieved.
- Reviewing the efficacy of measures taken by agencies to implement the objectives of the Board and to make and monitor recommendations.
- Undertaking child practice reviews, adult practice reviews, audits, investigations and other reviews as are required in pursuance of its objectives and to disseminate learning and information arising from these reviews.
- Reviewing the performance of the Board and its partners and bodies represented on the Board in carrying out its objectives.
- Facilitating research into protection from, and prevention of, abuse and neglect of children and adults at risk of harm.
- Review the training needs of practitioners working in the area of the Board in order to identify training to assist in the protection and prevention of abuse and neglect of children and adults at risk of harm.

Published CPRS /APRS

The Social Services and Well Being (Wales) Act 2014, states that the Regional Safeguarding Board must arrange for an Adult or Child Practice Review to be held where abuse or neglect of an adult or child is known or expected and the adult or child has:

- Died
- Sustained potentially life threatening injury or
- Sustained serious and permanent impairment of health

The purpose of the review will be to identify if there is any learning for future practice and to promote future improvements in relation to inter-agency professional practice. Learning events are held and it is mandatory to include the professionals who had involvement with the adult or child and/or family prior to the incident that led to the commissioning of the review.

The Practice Review Management Group is the platform from which these reviews will be undertaken on behalf of the West Glamorgan Safeguarding Board.

The Wales Safeguarding Procedures for children and adults at risk of abuse and neglect

The-Wales Safeguarding Procedures detail the essential roles and responsibilities for practitioners to ensure that they safeguard children and adults who are at risk of abuse and neglect.

The Procedures are designed to standardise practice across all of Wales and helps practitioners apply the legislation <u>Social Services and Wellbeing (Wales) Act 2014</u> and statutory safeguarding guidance <u>Working Together to Safeguard People</u>.

These procedures are intended to guide safeguarding practice for all those employed in the statutory, third (voluntary) and private sector in health, social care, education, police, justice and other services. They are applicable for all practitioners and managers working in Wales - whether employed by a devolved or non-devolved agency.

The procedures are updated regularly in line with changes to legislation, guidance and practice developments. The Wales Safeguarding Procedures app are available for download via Apple Store, and Google Play Store. Throughout the Procedures, there are hyperlinks to relevant legislation and guidance. These are available via www.safeguarding.wales along with webinars and more details on each of the sections.

West Glamorgan Safeguarding Boards' Recognition Awards Ceremony

As well as recognising individual's efforts, this will help maintain motivation for awardees, colleagues and wider safeguarding professionals and reflect that their hard work is valued by the Board.


Please note awards will be given under the following categories:

Feedback from National Safeguarding week 2020

Due to the pandemic, National Safeguarding Week 2020 took place virtually. It was unclear how effective this would be, however all service areas worked together and produced a large programme of events which proved to be the most successful yet.

The programme contained many events including the following two conferences:

PFAN - Parent, Family & Allies Network- Parent Advocacy – Development and Action Webinar

The conference held on 16.11.20 was part of the PAN project plan with a view to informing and learning from each other on a Wales wide basis. The conference intended to show how parent advocacy creates better co-operation and understanding between parents and social workers, reduces the need for compulsory statutory interventions and for children to be looked after by local authorities. The conference was a demonstration of how parent advocacy can promote genuine partnership based on parent voice and experience. We had a superb organising group. The event included an excellent line up of renowned academics and experienced parent advocates and was well attended with 164 attendees on the day (including speakers who were present). Despite technical problems in managing the system and difficulties with sound, the conference was successful in relaying profound messages of hope, and instilling confidence in a changing process where parents are supported to care for their children in a more humane climate of social support.

West Glamorgan Safeguarding Board - Practice Review Learning event

This was an online event where 3 practice reviews were presented to share the identified learning in order to improve systems and practice. The event ran successfully with 107 professionals in attendance via Microsoft Teams. The event also received positive feedback and it has been requested that these online learning events continue in the future.

Junior Safeguarding Board Update

The JSB are focusing on LGBTQ+ issues, equality & discrimination. Initial links have been made with the LGBT Group NPT Youth Service & Stonewall.

The JSB have made links with YMCA and are collaborating with Llamau, YMCA Swansea, and a group in North Wales on the above theme.

The JSB will be working with local LGBT groups in NPT secondary schools with the aim of creating a resource for school councils to use. This pack will then be piloted with a school in Swansea & NPT and finally distributed. Later in 2021 both projects will be celebrated.
